There is an additional 9 acres available with a packing facility, cold storage and office. There are multiple irrigation wells permitted for up to 16.5 million gallons of water per month from the Floridan Aquifer. The farm also benefits from proximity to the amenities of Marianna and the Florida Panhandle Beaches. 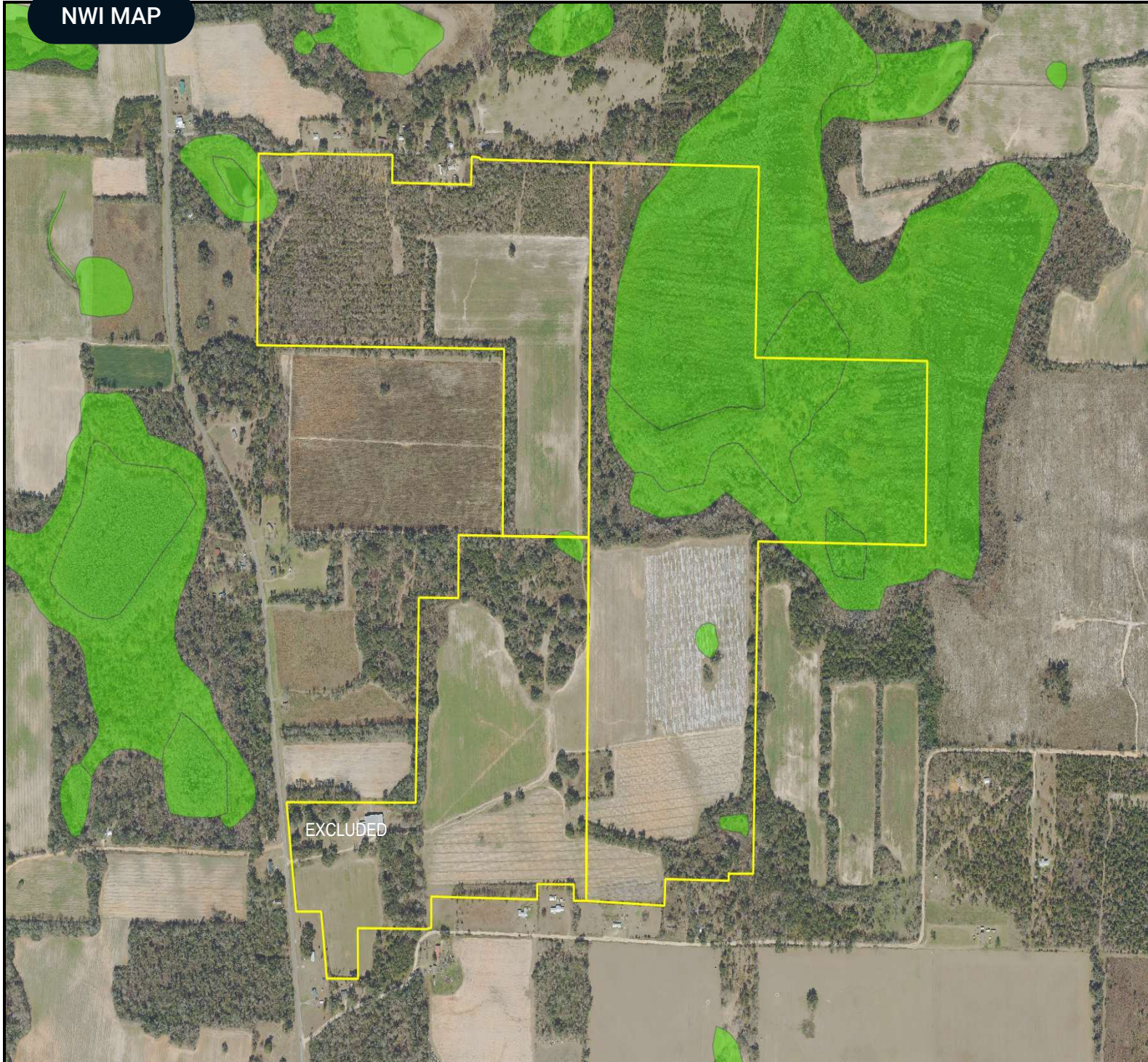

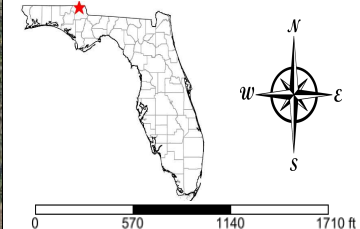
