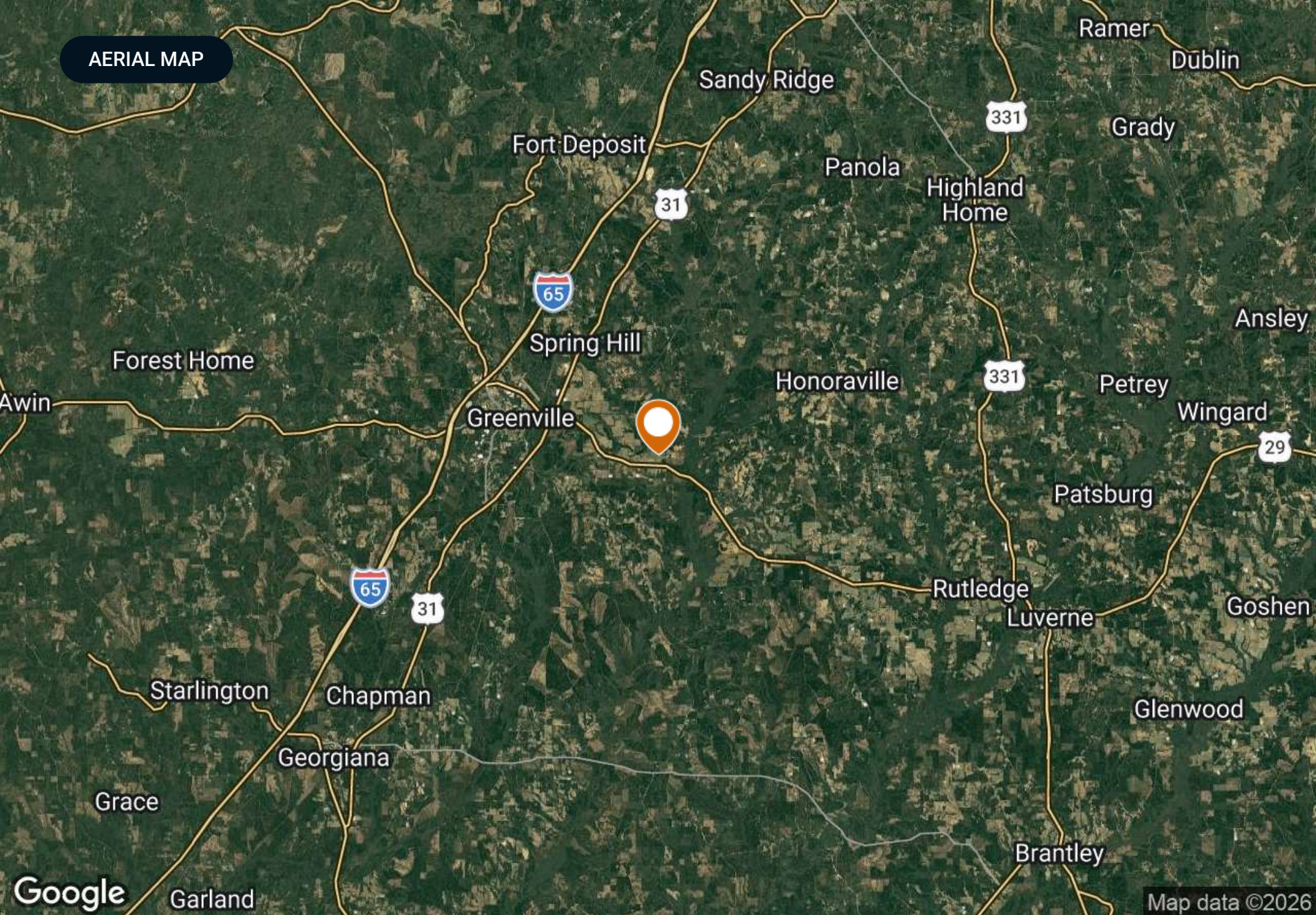

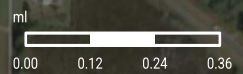
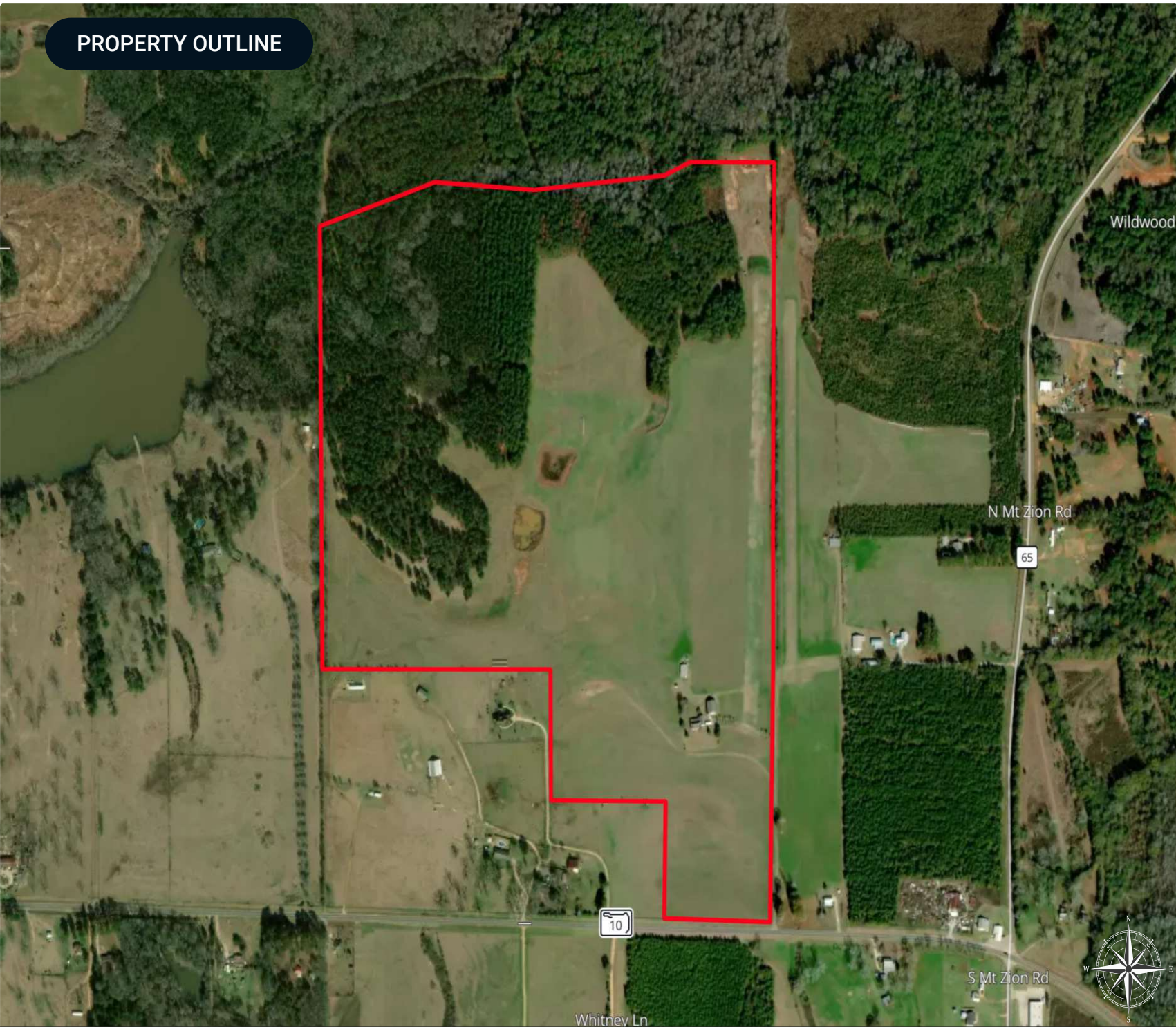
AERIAL MAP

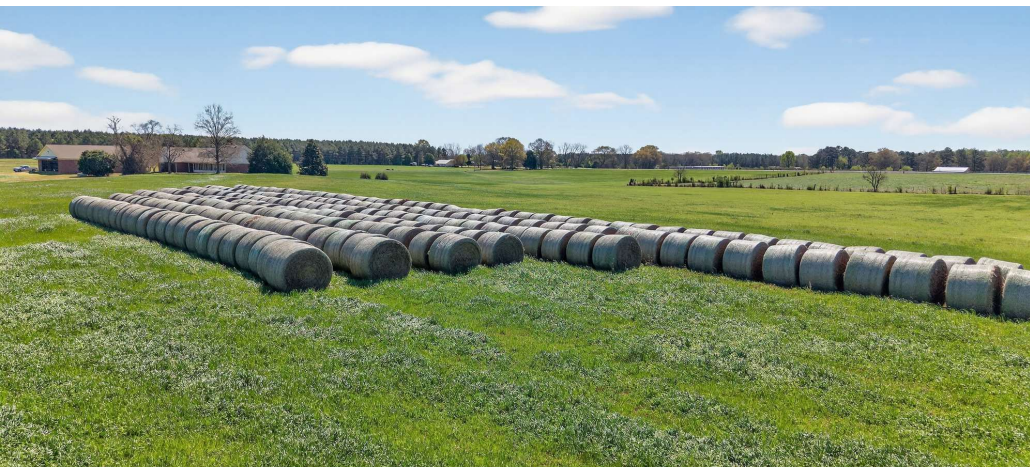

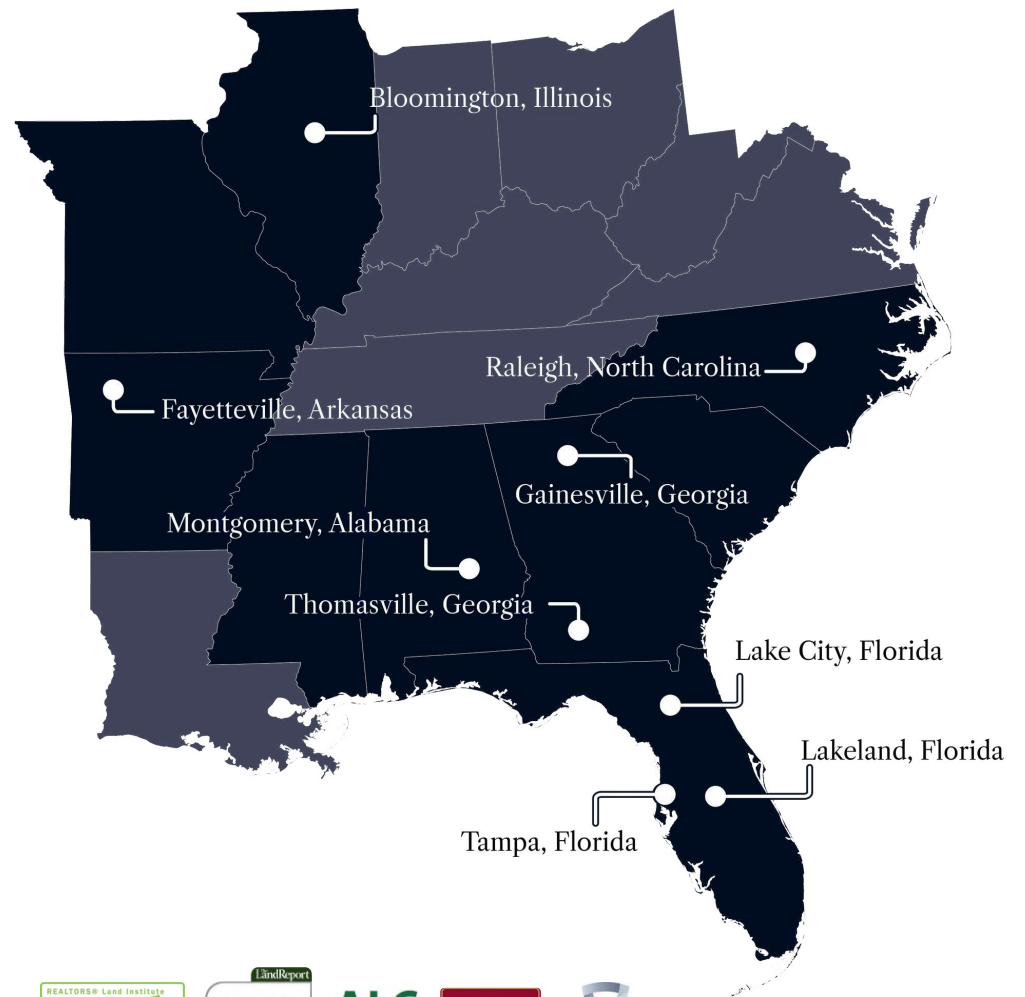
